Minutes of meeting held at 7.45pm on Tuesday 26th April 2016 at Over Peover Methodist Church, Cinder Lane.

16. 38Police Report - The police reports are issued monthly and will be put online. Any items of interest will be highlighted to the members.

16.39 Parishioners Question Time - None

16.40 To fill Vacancies on the Parish Council – Two candidates have expressed a wish to proceed. It was therefore proposed by TC and Seconded by Chris Hurst That Mt Phil Welch be co-opted as a member of the Parish Council and Mt Brian Glover Smith be co-opted as a non-voting community member of the Parish Council. This was unanimously agreed.

16.41 Minutes of the meeting on 24^{th} March 2016 – These were agreed and signed as a true record

16.42 Matters arising from the minutes – The issue of the local plan and the parish supplementary Planning document being adopted into it were raised. The Clerk is to write to Jeremy Owen at Cheshire East to ask where the SPD stands and to ascertain that the assurances we received previously that it would be retained were still so. If Possible Mr Owens is to be invited to the next meeting to discuss the local plan as part of the Annual Parish meeting.

The Clerk is to write to Samuel Smiths to ask for an update on the old Fire Station. The Issue of Pepper Street has been repeatedly highlighted to Cheshire East highways and the clerk has been advised that it is on a priority list for works this year. However the reporting of Potholes and highway issues can and should be done by all member s of the pubic via the online reporting or by telephone. This is to be added to the newsletter.

The new 20mph zone is coming in to play making the relocation of the 30mph sign on Chelford Lane a priority. Ian Webber is to contact Simon Wallace regarding this. John Caulfield is willing to take on Speed watch from Ian Webber and look at doing some sites on the A50 as well as in the village.

Ian Hayes has asked for some help in the eradication of the Himalayan balsam. This is to be included in the newsletter.

16.43 Finance - The receipts and payments report was presented to the meeting and the figures and payments agreed.

The Bank reconciliation was agreed and the online payments were signed off. The internal audit is to take place in the next month.

16.44 Planning – The plans presented to the meeting were discussed and comments submitted online where relevant.

It was also felt wise to ask James Hardy and Barry Wienholdt for their comments.

16.47 Housekeeping and maintenance

Play matting on swings, slide and rocking horse - Waiting for a response on the S106 team

Drainage on Parish Field - levels are being done and then the work needed can be assessed.

Noticeboards and Benches – no luck in getting quotes but Keith White is willing to take on this task and so with the meetings approval the clerk is to ask him to do so.

Signage - Awaiting quotes for fitting and replacing. No Dogs Allowed sign to be replaced on Parish Field.

16.48 Update on ongoing projects

Broadband - meeting had with Andrew Arditti, Glen Fendall, Geoff Nichols, Kathy Doyle, George Walton, Brian Glover Smith and the Clerk.

40 of the original properties are to be included in Phase 2 and this leaves approx. 60 houses without a solution. Therefore looking to get these included in phase 3.

There is also a possible funding reallocation of the satellite subsidy to be redirected to pay for the cabinet or solution for the remaining 60 properties.

The next step is to push for each deadline from Andrew and Glen to be met (1st June) and if we get nowhere there is a case for involving George Osborne.

Footpaths - Landowners have been contacted. Awaiting a response.

AED - Awaiting grants.

Christmas Tree Lights - Phil welch has taken on the issue and has made good progress with the necessary cabinets and costs. The meeting asked him to ascertain what the final costs would be and email that round to the parish council members with a view to finally agreeing this project.
