Minutes of meeting held at 7.45pm on Tuesday 22nd March 2016 at Over Peover Methodist Church, Cinder Lane.

16.26 Apologies for absence: John Caulfield, George Walton Liz McGrath

16.27 Declarations of Interest in any agenda item: BGS as a neighbour to the Maples planning application 16/1242M

16.28 Parishioner's Question time

Four members of the public were in attendance. Vicky Irlam raised concerns over plans at Colshaw Hall Farm not their detail which she supported but to the possibility of a non farming use. Ed Dale and David Irlam gave an overview of the plans and suggested that they required additional space for livestock particularly early calves and to make the unit more efficient. That they wouldn't do anything to overtly cause a nuisance to neighbours not least as Colshaw Hall was the nearest neighbour and it would be detrimental to David's wedding business which wouldn't make any sense.

Glyn Hesselwood raised three concerns. Firstly, that a significant amount of work had been put into developing a Parish Plan which had been adopted by the Council. Glyn wanted to seek the PC's support in making representations to the Council regarding the latest 'local plan' consultation to ensure the Parish Plan was acknowledged and maintained in this new framework as a material consideration. Secondly that the state of the roads and in particular pot holes on Pepper Street and Chelford lane was a disgrace and led to damage to both his own and his wife's car. Thirdly to ask if Sam Smiths brewery could be approached to expedite the development of the 'old fire station'

The Chairman responded to Glyn suggesting the PC had always made strong representations reference the Parish Plan to the Council in the past and whilst the local plan had yet to be discussed at PC he believed it highly likely they would again fight for its recognition. That there was a website to register pot holes and encouraged Glyn to register any that caused concern, that there was a dedicated highways councillor on the PC and regular dialogue with the Council over the poor state of roads. That there was regular dialogue with the brewery and it was the PC's belief that the old fire station would be re-built but to date they hadn't been able to secure a timeline.

16.29 Planning

The Colshaw Hall farm plan 16/1204M was discussed and it was agreed there was no objection. The clerk would be advised for consistency to make comment in-line with previous

agricultural business development growth in terms of the PC's support and previous comments around calving operations.

16.30 To approve the Minutes of the last Meeting on 23rd Feb 2016. -the minutes were agreed and signed as a correct record.

16.31 To discuss matters arising from the last meeting, not already covered in the agenda -

BGS, JH and PW were asked if they had their declarations of interest and were asked to sign acceptance of office / code of conduct. BGS and PW supplied signed documents. JH felt it may be better to have a single voted in councillor. A debate took place and the PC's position remained as the last meeting in that they would like to encourage the wider participation and the engagement of all 3 individuals. JH will consider his position for the next meeting.
