c. Consider Cheshire East Housing SPD Consultation

There was a short discussion on this consultation document. The sections which affect Over Peover are Section 5 Housing Design and Section 6 Housing Mix. There should be emphasis on the importance of a mixture of housing types to provide appropriate accommodation for a range of households. The environmental impact of housing on climate change needs to be recognised, in particular the effect of embedded carbon in existing structures.
