23.20 Receive apologies for absence

Apologies received from Cllr Katy McAinsh. No apologies received from Ward Cllr Marc Asquith

23.21 Receive questions or comments from the public

a. Approve the Receipts and Payment Report

The Receipts and Payments report was reviewed and approved. The Chair suggested that, in view of the asset value of the Parish Field equipment being in excess of £60,000, the Parish Council should build up ring fenced funds so that equipment can be replaced when needed.

23.28 Housekeeping and Maintenance

a. Update on list of ongoing issues

- Section 106 funding The parish council has now received £10335 in S106 funds. A further £4000 is due to the parish council. The Clerk has requested the funds from CE Council and will continue pursuing.
- ii. Fire Station -Cllr Irlam contacted Mark Butler again and awaits a response.
- iii. Speed Limit Reduction No update from CE Highways. It was reported that Barclays will support the parish council's request.
- iv. CE Planning Enforcement An objection was registered against the grain store at Colshaw Hall Farm. Planning Enforcement disregarded the objection following a visit in which they found grain stored on site.

The Chair to pursue the Nine Oaks application following concerns over the length of time taken by Enforcement in dealing with the application.

- v. Snelson PC Merger –Barclays Bank has amended the account type from Club/Society to Local Authority. The account name will be updated by the end of the month.
- vi. Helipad No update since the last meeting
- vii. Community Speed Watch No update since the last meeting. A request for volunteers was included in the newsletter.
- viii. Website Update/IT Cllr Gunter has upgraded the website and will soon add the Snelson pages. Krystal Hosting are not able to make the website compliant with Accessibility guidelines so Cllr Gunter will ask a colleague for assistance once the website is up and running.

b. Purchase of new noticeboards

The Chair had previously circulated quotes for new noticeboards and, following much discussion, Members agreed the Chair should choose the boards. It was agreed they should be black with gold lettering and the parish council will arrange the installation.
